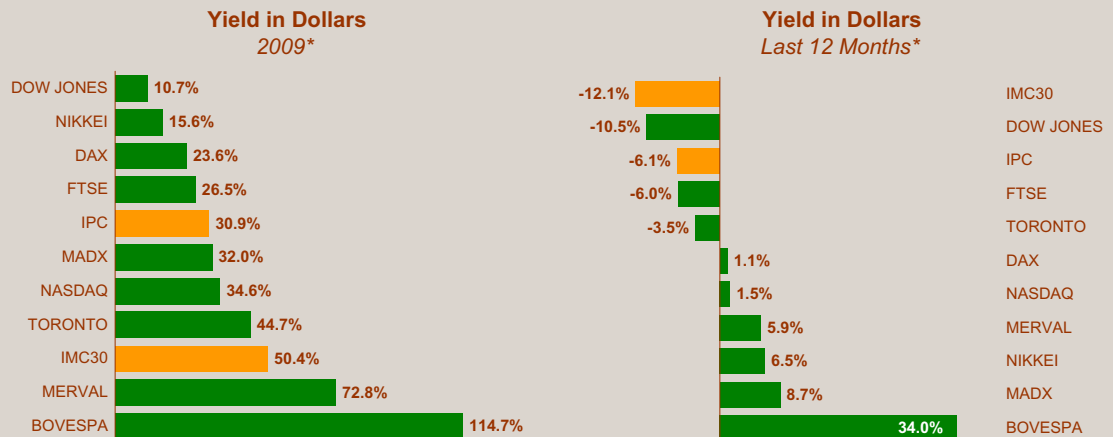

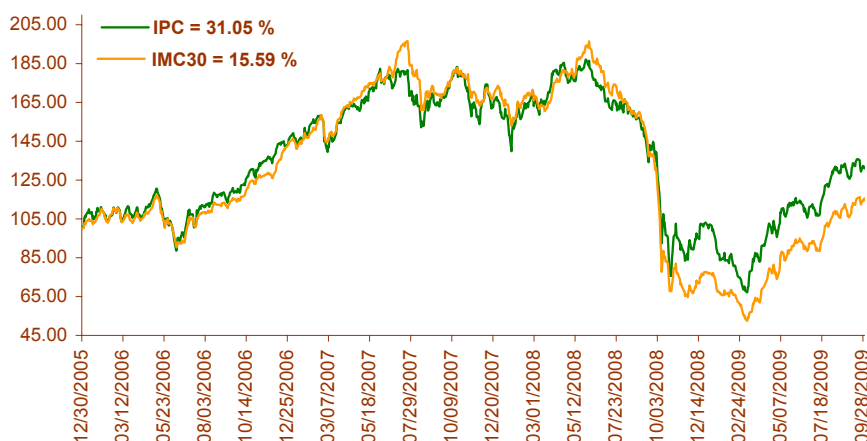

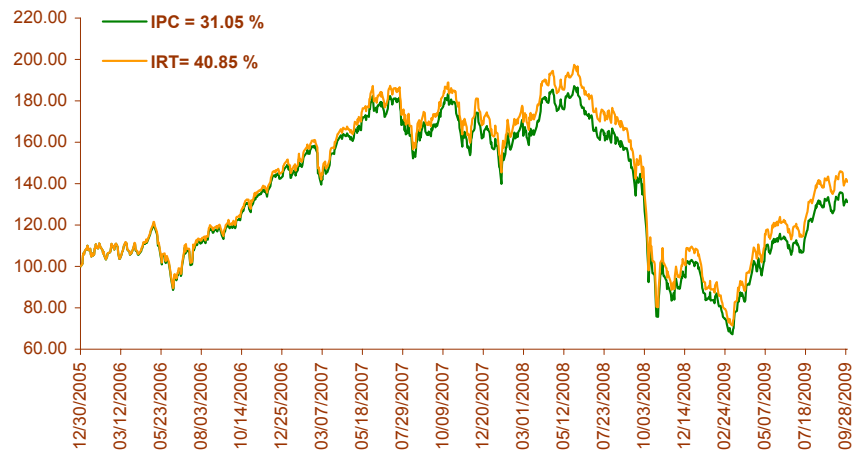
IPC and IMC30 Behavior in Dollars in Base 100
Dec 30th, 2005 - Sep 30th, 2009



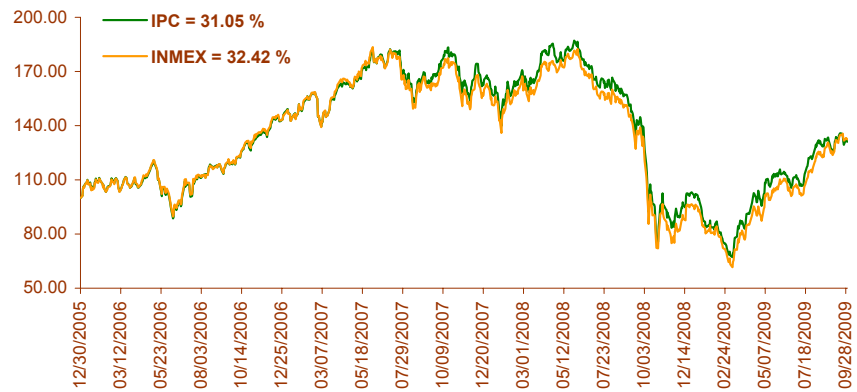

Dec 30th, 2005 - Sep 30th, 2009



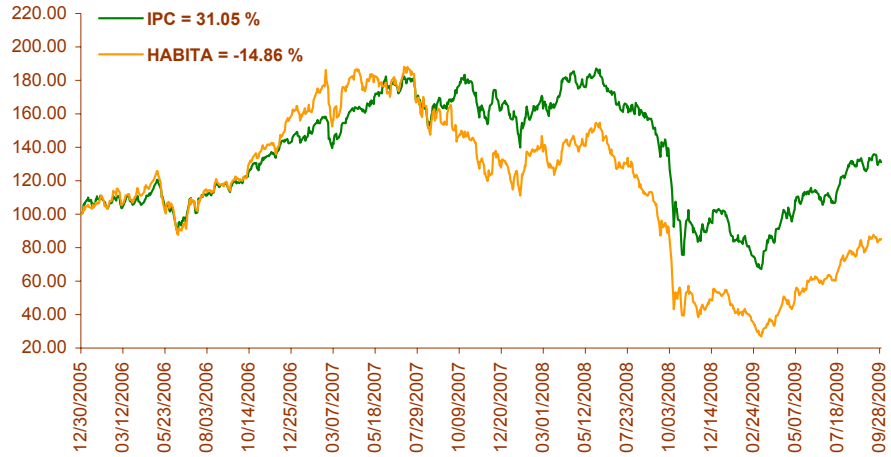
IPC and INMEX behavior in US Dollars in Base 100
Dec 30th, 2005 - Sep 30th, 2009



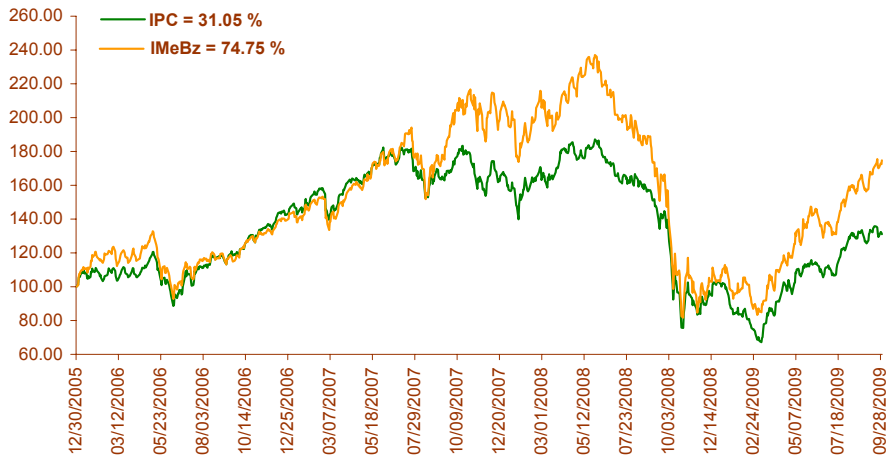

Dec 30th, 2005 - Sep 30th, 2009



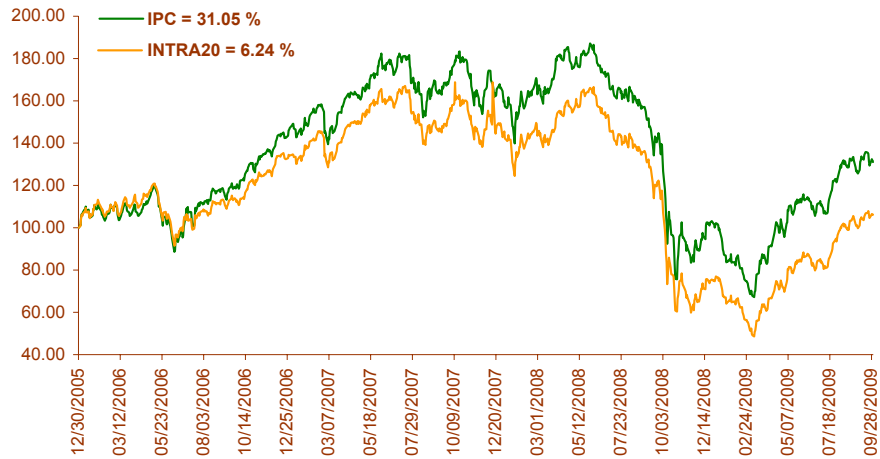
IPC and IMeBz behavior in US Dollars in Base 100

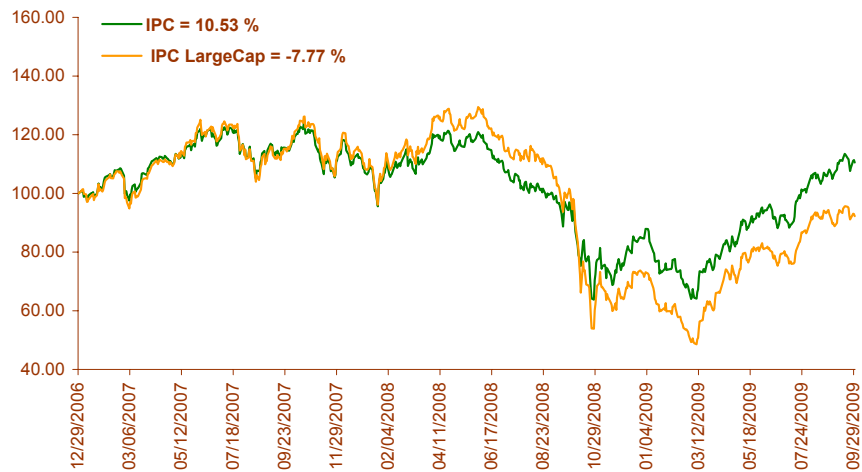

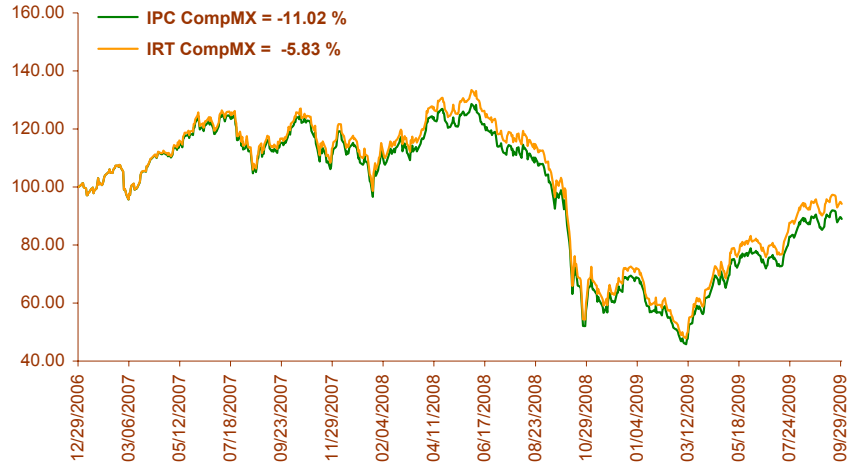
IPC and IPC LargeCap behavior in US Dollars in Base 100

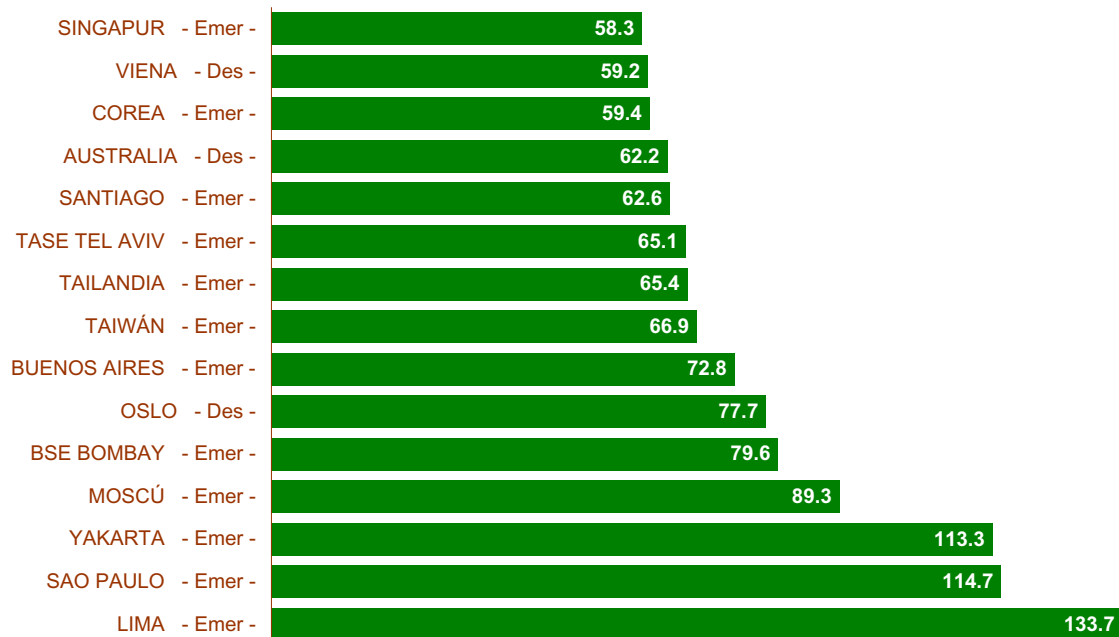

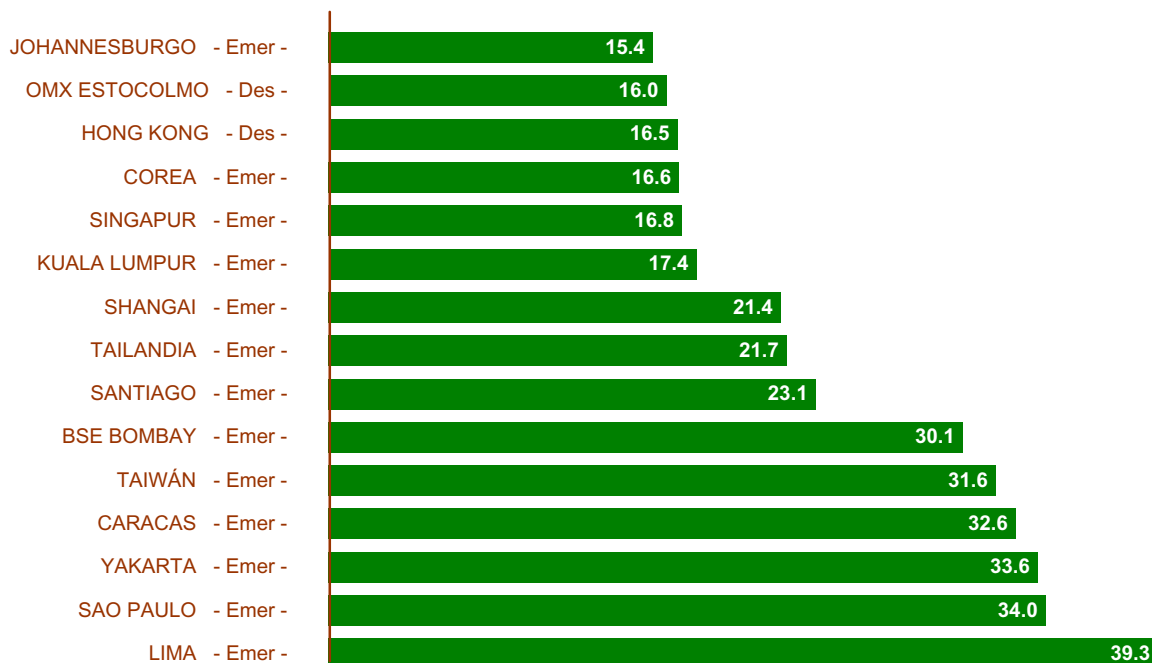

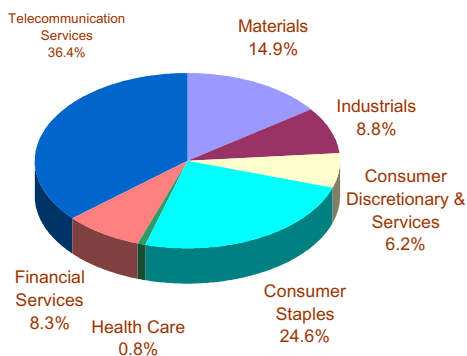

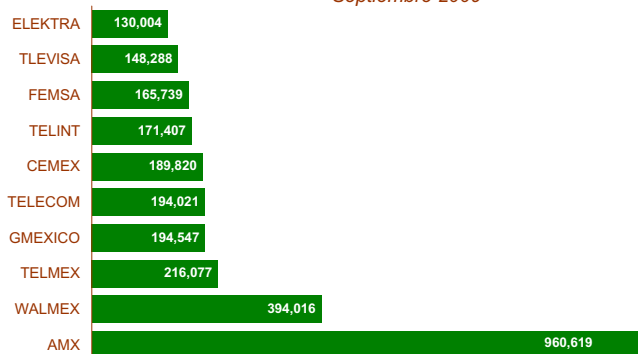

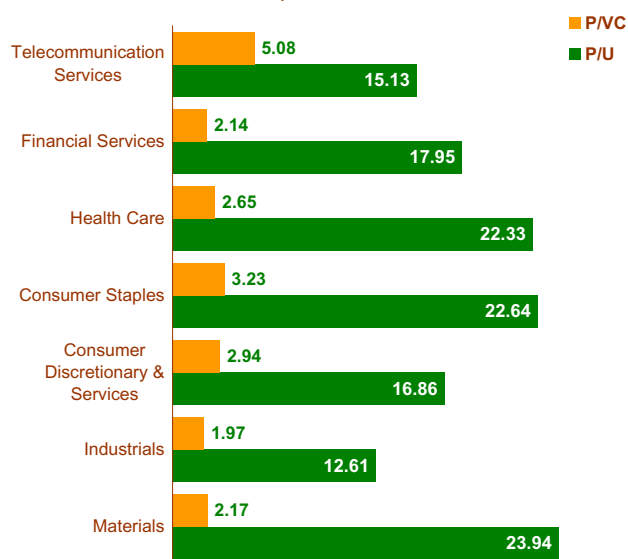

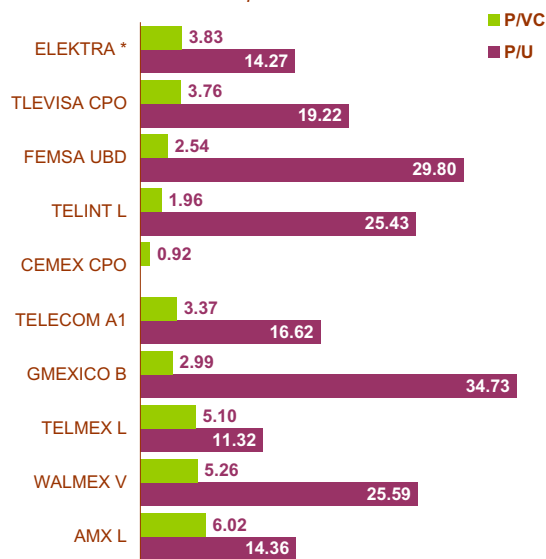
