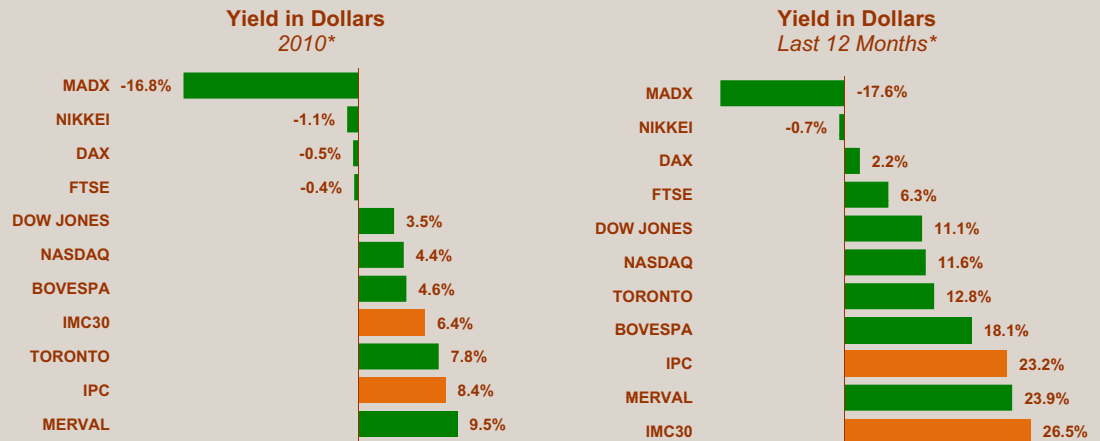

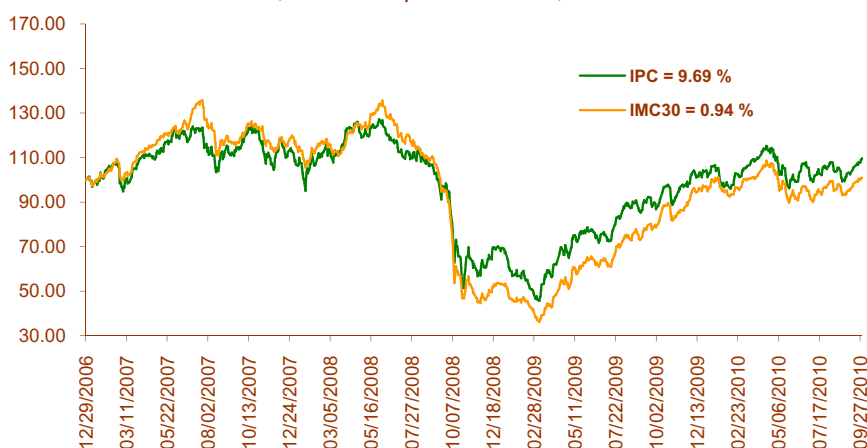

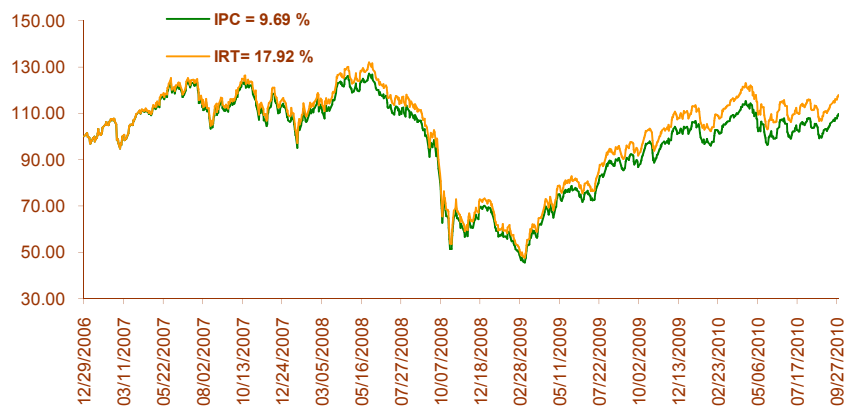
IPC and IMC30 Behavior in Dollars in Base 100
Dec 29th, 2006 - September 30th, 2010



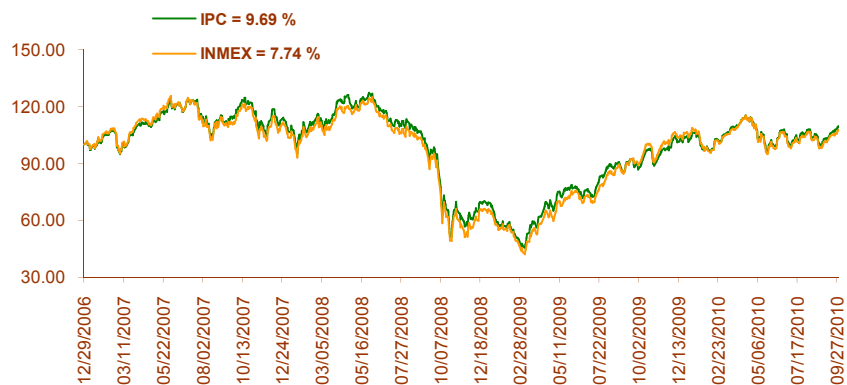

 Dec 29th, 2006 - Sep 30th, 2010



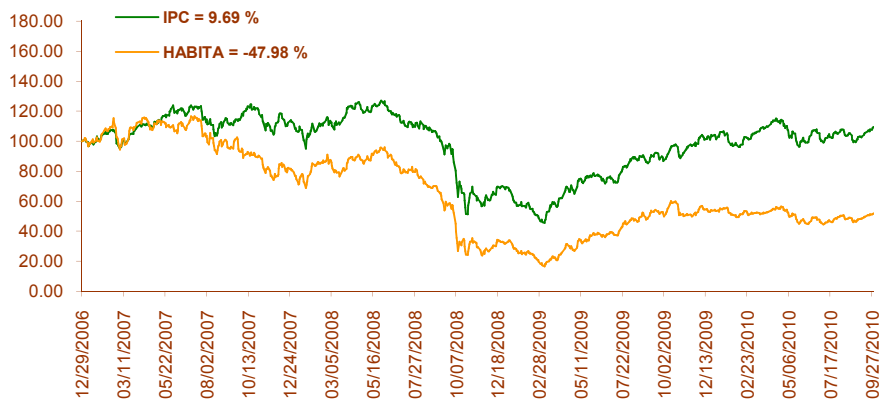
IPC and INMEX behavior in US Dollars in Base 100
 Dec 29th, 2006 - Sep 30th, 2010



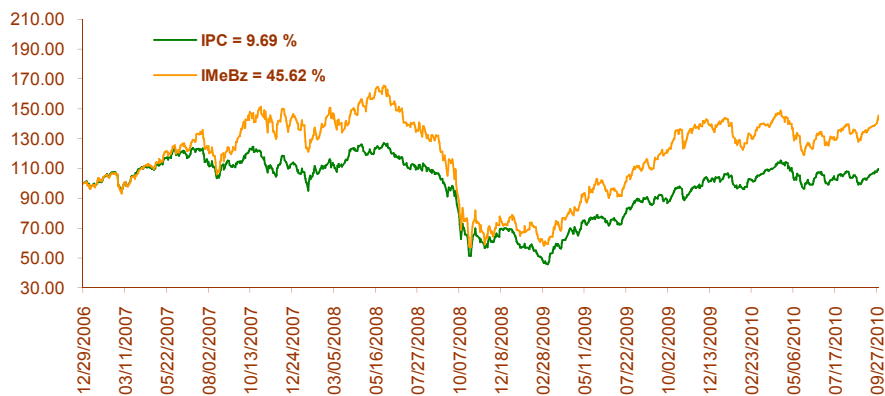

 Dec 29th, 2006 - Sep 30th, 2010



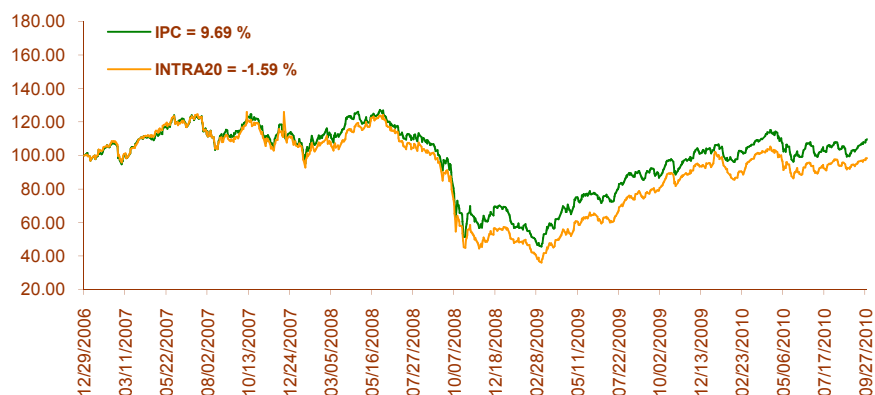
IPC and IMeBz behavior in US Dollars in Base 100
 Dec 29th, 2006 - Sep 30th, 2010



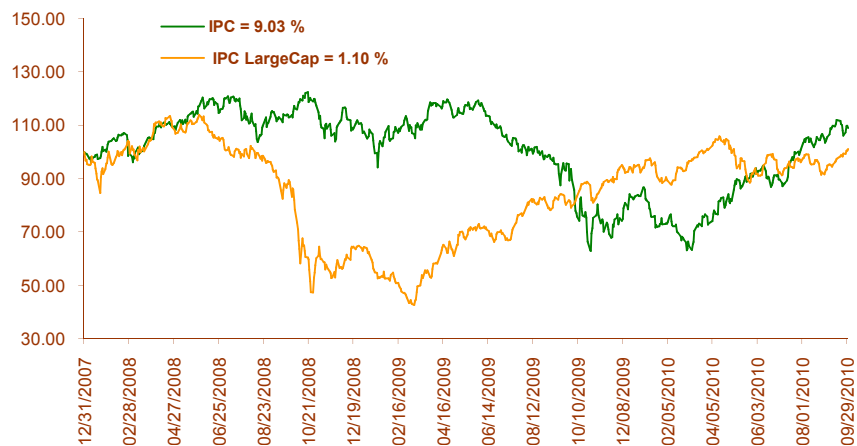

Dec 29th, 2006 - Sep 30th, 2010



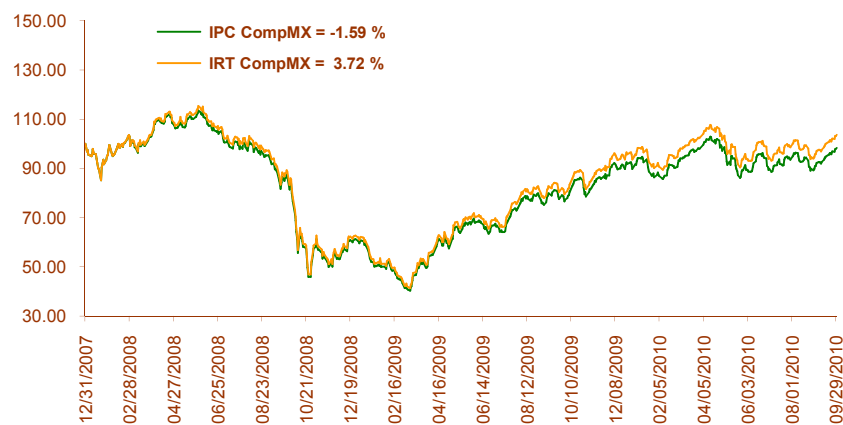
IPC and IPC LargeCap behavior in US Dollars in Base 100

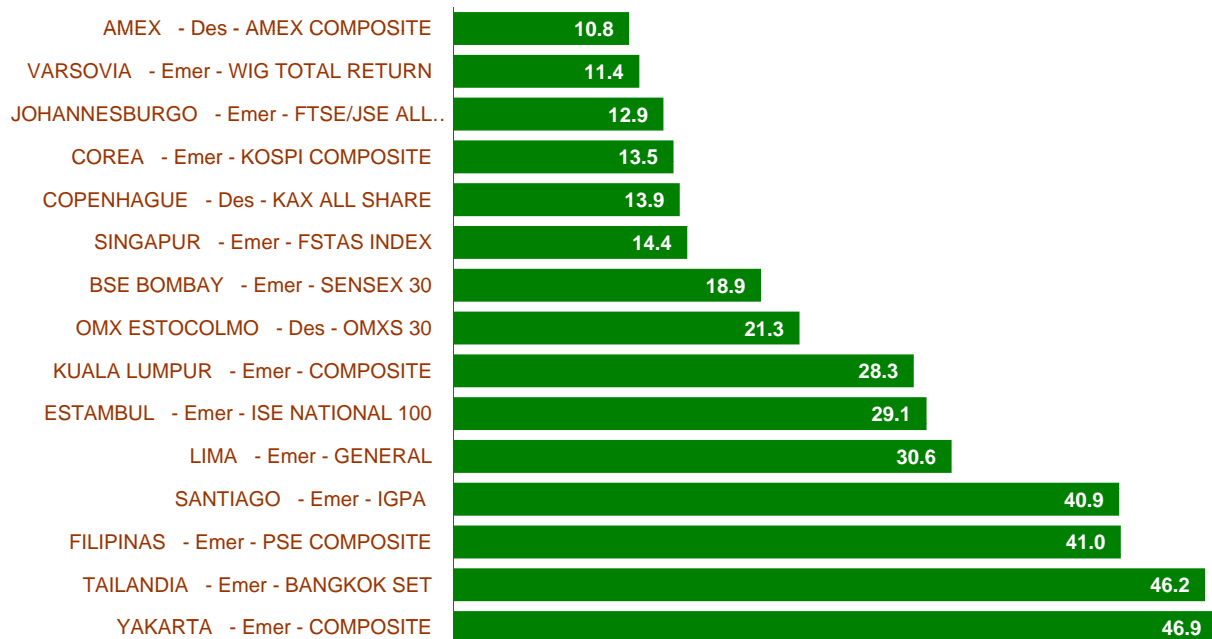

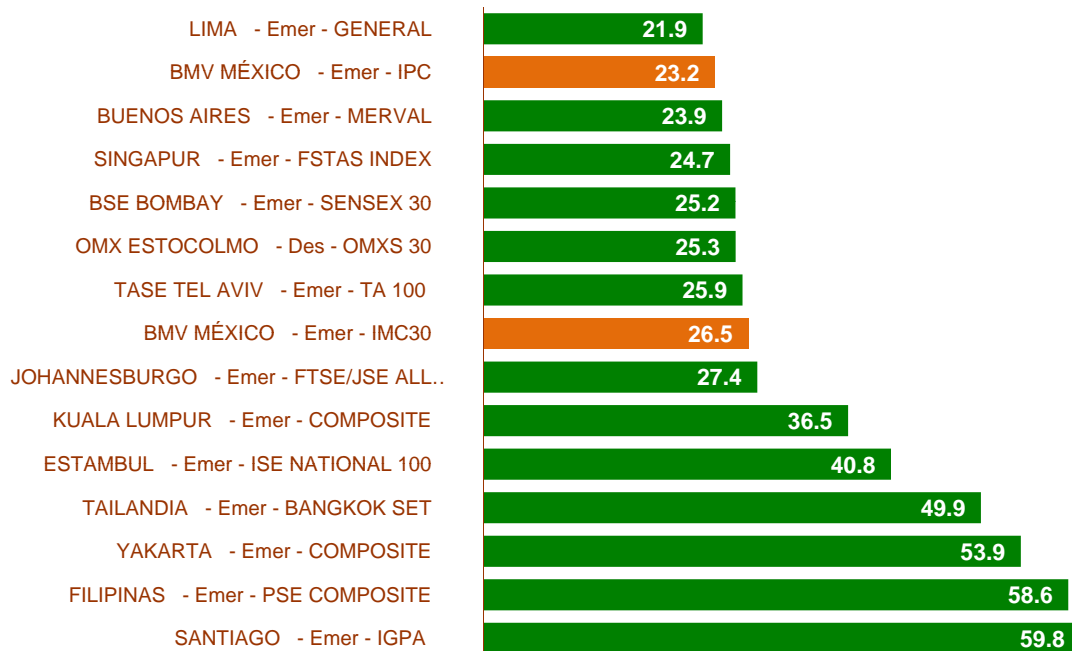

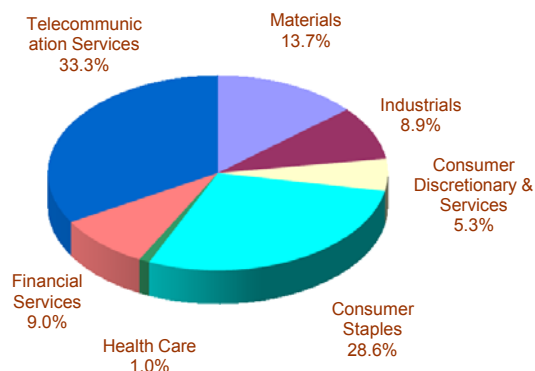

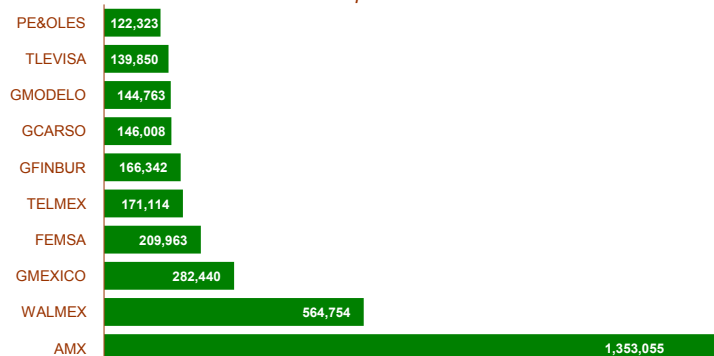

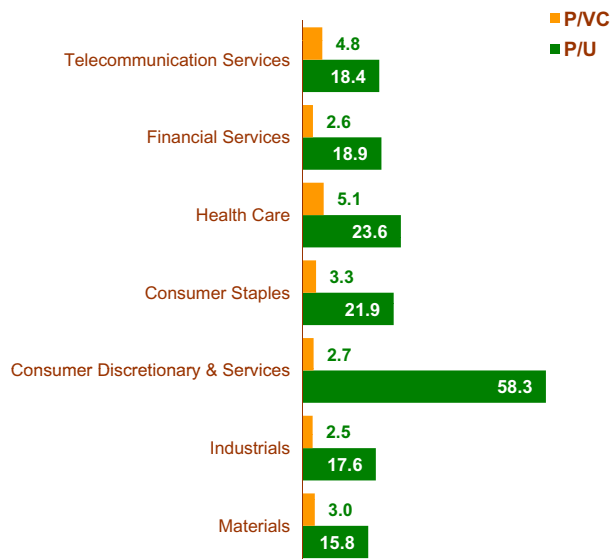

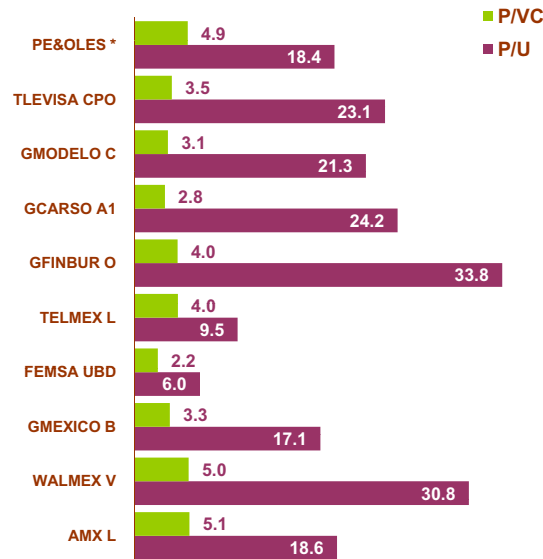

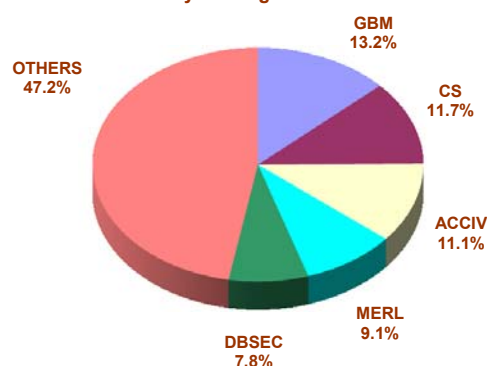

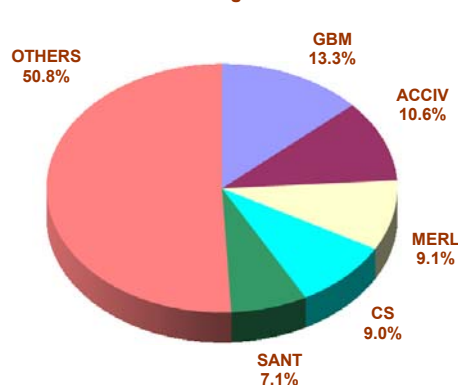

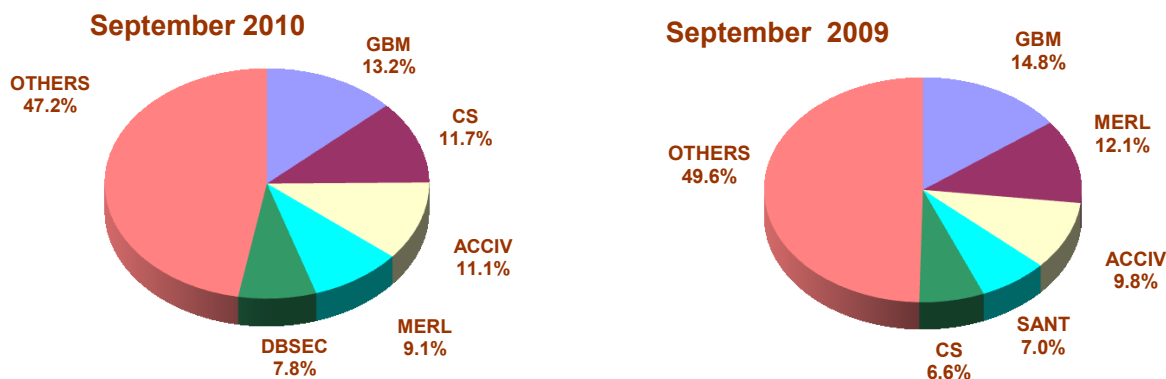

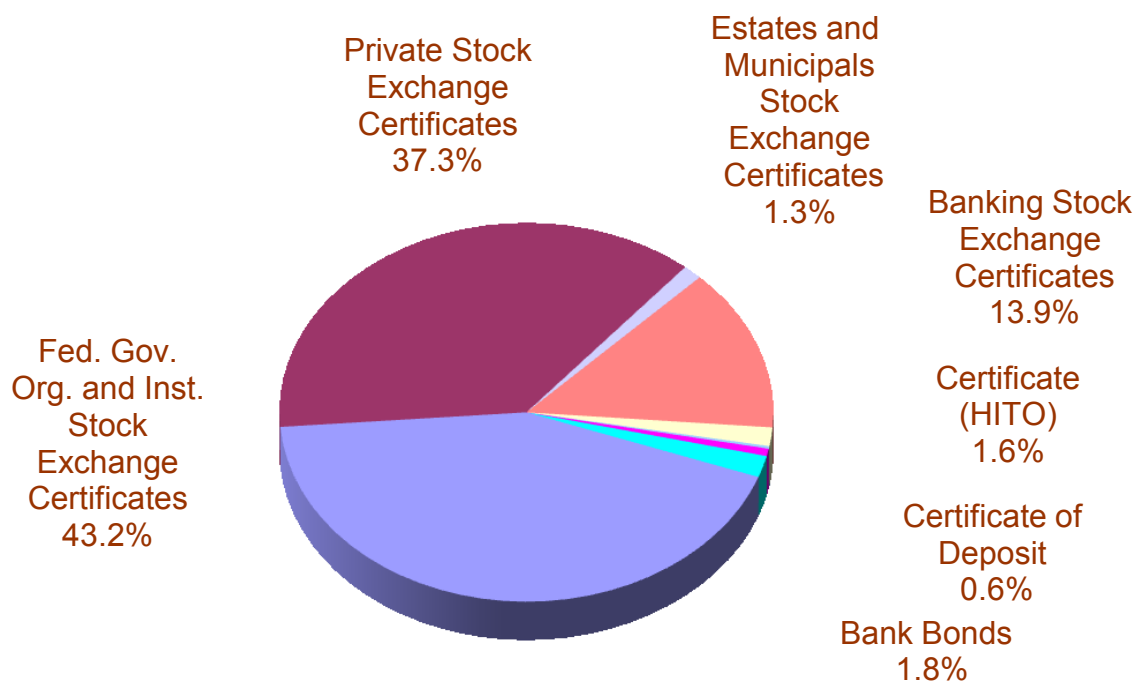
